I absolutely and entirely renounce relinquish and abandon the use of my said former surnames of JAN MAREK MUCHA and JOHN MARCUS OMOND MUCHA and assume adopt and determine to take and use from the date hereof the surnames of JOHN MARCUS OMOND in substitution for my former surnames of JAN MAREK MUCHA and JOHN MARCUS OMOND MUCHA

I shall at all times hereafter in all records deeds documents and other writings and in all actions and proceedings as well as in all dealings and transactions and on all occasions whatsoever use and subscribe the said name of JOHN MARCUS OMOND as my surname in substitution for my former surnames of JAN MAREK MUCHA and JOHN MARCUS OMOND MUCHA so relinquished as aforesaid to the intent that I † [my wife and my children] may hereafter be called known or distinguished not by the former surnames of JAN MAREK MUCHA and JOHN MARCUS OMOND MUCHA but by the surname of JOHN MARCUS OMOND only.

3. I authorise and require all persons at all times to designate describe and address me † [my wife and my children] by the adopted surname of JOHN MARCUS OMOND

In Witness whereof I have hereunto subscribed my Christian or first name and my adopted and substituted surname of JOHN MARCUS OMOND and also my said former surnames of JAN MAREK MUCHA and JOHN MARCUS OMOND MUCHA and have affixed my seal the day and year first above written.
